"STANDING ON THE SIDE OF LOVE" CAMPAIGN TO BECOME MORE INCLUSIVE

Perhaps the most exciting news in the ongoing work to address ableism within Unitarian Universalism was the passage of a <u>Responsive Resolution</u>. Rev. Theresa Inez Soto, a powerful disability rights advocate and active member of EqUUal Access, put forth the resolution calling upon the leaders of UUA to replace the language of the "Standing on the Side of Love" with language that "better includes and reflects the needs and

contributions of disabled people." After some debate, the resolution passed overwhelmingly. It was a historic moment when ableism was at last recognized within Unitarian Universalism.

PROGRAM CHANGES

As a new program, we are continually working to improve our materials and program design based on the feedback we receive from congregations. We appreciate your patience when a change is made and welcome your input.

AIM ADVISORY TEAMS

During our first year as a "live program," each AIM Aspirant Congregation has been assigned to a Review Team once accepted into the program. But we've noticed that congregations are having less contact and struggling more than congregations that went through the pilot program.

In an effort to provide AIM Aspirant Congregations with the "missing ingredient" that pilot congregations told us helped them to be successful, we are changing the program model. AIM Review Teams will be getting a new name and a different role as AIM Advisory Teams. Advisory Teams' goal will be to provide mentoring, guidance, and resources to support congregations throughout their participation in the AIM Program.

We ask your patience as members of Review Teams are trained for this new role. You can expect to begin hearing from your Advisory Team members more often in the coming weeks and months. Please help us to make this change in program design successful by doing your part to keep in contact with your AIM Advisory Team.

NEWS FROM AIM-ASPIRANT CONGREGATIONS

Wonderful disability-related work is happening all the time at congregations participating in the AIM Program. We'd like to recognize just a few of the accomplishments from congregations who are in Phase III of the AIM Program, or were recently certified. During Phase III, congregations are actively working on completing their AIM Plan.

First Parish in Bedford, MA: social justice project working with veterans in new housing units of the local VA campus.

Unitarian Fellowship of Hartford, CT: installation of a hearing loop system in the Sanctuary.

PHASE III PACKET UPDATED

Formerly called Packet C, the newly update Phase III Packet is now available on the UUA website: <u>Phase</u> <u>III Packet</u>.

RECERTIFICATION REQUIREMENTS

Certification last a period of three years, after which congregations re-apply. The requirements are now clearly explained and posted on our UUA web pages: <u>AIM Recertification Requirements</u>.

COMING SOON

We are also working on improving the Phase II Packet Assessments, formerly called Packet B, so stay tuned.

The new assessments will be broken down into subject areas, i.e. "Worship," "Entrance & Egress," "Religious Education." We hope the assessments will become much less daunting when broken into components that can be completed by small groups of appropriate individuals.

The new Phase II Packet will provide clearer guidance on how to use the assessments as tools for engaging different groups in the congregation in the AIM Program. Each assessment component will include recommendations for individuals who should work together on that component of the assessment. When an AIM Team member, members of the board, and staff members have an opportunity to sit down together to work on the policy component of the assessment, for example, the AIM Team member can educate everyone on what AIM is and generate enthusiasm for the program, while all parties develop an understanding of what the inclusion and accessibility priorities are. Unitarian Universalist Church of Buffalo, NY: invited nationally recognized queer and disability activist Eli Clare for their annual disability service; organized a book reading and signing of Eli's new book <u>Brilliant</u> Imperfection.

Unitarian Universalist Church of Long Beach, CA: held a workshop on disability activism attended by 20 people and participated in usher/greeter training.

Unitarian Universalist Church of Rochester, MN: after much hard work and effort, this congregation's website has become an example of a Welcoming website on our UUA webpage,
