Is Your Congregation Ready for AIM?

The Accessibility and Inclusion Ministry Program (AIM) engages congregations deeply in understanding the meaning and experience of disability, in the congregation and in our world. AIM is a partnership between the Unitarian Universalist Association and EqUUal Access. In the tradition of Welcoming Congregation and Green Sanctuary programs on which it was modeled, AIM certifies congregations as committed and engaged in becoming accessible and inclusive religious communities.

Each congregation accepted into the AIM program sets its own pace for obtaining certification, though most can anticipate taking from 2 to 3 years.

It begins with the formation of a local core AIM group or team, and getting the support of the congregation's leaders. Each local AIM team is assigned a dedicated Advisory Group upon entering the program. Using email and Zoom internet meetings, each AIM team will regularly meet with, and receive ongoing guidance and feedback from AIM program coordinators throughout the process.

Detailed AIM Assessment tools help the local AIM team and congregation identify the current degree of accessibility and inclusion, and determine which priorities to address. An AIM Action Plan is created, based on these priorities. Once approved, the AIM team begins to engage their Action plan with their congregation. AIM certification criteria includes effecting a required number of workshops, projects, and disability themed worship services. When the plan is completed, it's time for review and certification is awarded.
